April 10, 2023

Call to Order: The meeting was called to order by President Lisa Roethlisberger at 4:03 p.m.

The security system was installed.

The Downtown Development Authority assessment needs to be looked at.

A stabilization fund will need a policy change.

New programming is going very well.

New Business: Michelle Duclos did a line item review of the budget proposal for 2023-24. The budget will be voted on in May.
